


INTRODUCTION

The stakeholder engagement during the budgeting time for the year 2024 was conducted on the 2nd November 2024. This is per guideline according to the Ministry of Finance. The team of Facilitators was led by the Chief Accountant Mr. Kelvin Pembele and the meeting started at exactly 10:00 hrs with a prayer from Mr. Alifas Phiri a zonal representative from Mawanda Ward. The following were the stakeholders invited;

- Two Ward Development Committee members from each Ward

During the presentation Mr. Mwale Simon a Ward Development Committee Member noted that the idea of having an IDP in the District was a good idea and thanked the organization that sponsored the IDP for the sponsorship.







After the Environmental Planner finished with the presentation, the house was allowed to break into groups and select the secretary and the chairpersons so that they could come back to do submissions. And they were given total of 30 minutes to carry out the activity.

A successful group work was done from all the groups and submissions were given. Some of the projects that were submitted included; Construction of a police post in Ukwimi Ward and Mawanda Ward, construction of a maternity annex at Nyaluwiro Health post, putting up of nine boreholes in every ward of the district, construction of a boarding secondary school in Sandwe area and considering rehabilitation of most government houses in the district.

After a number of submissions, deliberations were made regarding the said submissions. Then the moderator asked the house if there was any other business. One question was asked from Mr. Elliot Tembo the Planner under Ministry of health asked if all the submissions that were made were going to be implemented in the period under consideration. In response the Chief accountant stated that it was all dependent on the availability of funds and if fund were not available some projects are supposed to be pushed to the next year. The meeting finished with a prayer from Mr. Salulani Nkhata a WDC representative from Mawanda.


